## Product type:

lint-free non-woven quality (see delivery forms) with con- in the dispenser tub. Before using the product on large solidated fibers for cleaning and disinfection of non-invaareas of sensitive materials like artificial leather, first sive surfaces. The wipe impregnation system has been test the material tolerance on a small, hidden area. To tested with the four-field test (EN 16615) and is accordingly VAH-listed as an independent product. The impregnating liquid used, Dentalrapid soft SD liquid, is also VAHlisted.

Type of application: As per the Medical Devices Law (MPG): Alcohol-free wet wipes for the prophylactic surface disinfection of non-invasive medical products. Particularly suitable for use on alcohol-sensitive surfaces like acrylic glass.

# Indication for use:

Remove the stick & lift label from the bag, stick it onto the intended dispenser tub and enter the use by date etc. Open the bag at the top and place it in the intended dispenser tub. Pull on the first wipe of the roll and thread it through the lock in the lid clip. Push the lid down onto the tub and close it. Carefully wipe the area to be disinfected and let the disinfectant take effect. Always close the container.

Alcohol-free, ready-to-use disinfectant wipes in special After opening the bag, the wipes can be used for 28 days prevent streaks forming, the treated areas should be wiped dry at regular intervals with a damp (with water) disposable cloth. The disposal tub is to be prepared in accordance with the adjacent preparation guidelines, using a suitable disinfection cloth. During application, suitable gloves (e.g. made of nitrile rubber) are to be worn.

# **Spectrum of effectiveness:**

Bactericidal (incl. MRSA) as per VAH, EN 13727, EN 13697, EN 1276, EN 16615; levurocidal (candida albicans) as per VAH, EN 13624, EN 13697, EN 1650, EN 16615; "limited virucidal effect" (effective against enveloped viruses such as SARS-CoV-2, HBV, HIV, HCV); rotaviruses as per RKI/DVV; noroviruses as per EN 14476.

Effectiveness of the impregnated wipes as per EN 16615 and VAH (dirty conditions): conc. 1 min.

#### **Documentation of cloth impregnating systems:**

Lift the complete Lift & Stick label from the bag, stick it onto the container and fill in the opening and expiry date (+ 28 days).

## **Preparation guidelines:**

The dispenser is to be prepared with a suitable disinfectant wipe or solution, e.g. Dentalrapid SD liquid in accordance with the preparation guidelines below. During application, wear suitable gloves (e.g. made of nitrile rubber). For Dentalrapid SD wipes L this procedure is not necessary.









- 1. Open the dispenser
- 2. Disinfect the container and lid from the inside and outside (notice application time).
- 3. Let it dry
- 4. Open the new bag, put it into the container/dispenser, pull the wipe through the lid and seal it tightly.
